Mid-State portion of your dues is 100% tax deductible.

The amount of CAR Dues which are dedicated to lobbying and therefore non-deductible is 27% of \$155 (\$42).. The nondeductible portion for NAR is 32% of \$80 (\$26).

The \$10 CAR Issue Advocacy Assessment portion is not deductible. The NAR Image Assessment fee is deductible. The assessment fee for both NAR and CAR is not subject to pro-ration.

Affiliates do not pay NAR dues or assessment.
