I also acknowledge that if accepted as a member, and I subsequently resign from the board or otherwise cause membership to terminate with an ethics complaint pending, the Board of Directors may condition renewal membership upon my certification that I will submit to the pending ethics procedure and will abide by the decision of the hearing panel. If I resign or otherwise cause membership to terminate, the duty to submit to arbitration continues in effect even after my membership lapses or is terminated, provided the dispute arose while I was a REALTOR®. **Upon the termination of my membership for any cause, I will discontinue the use of the designation "REALTOR®"**.
